IMPACTION CAN BE CAMPUS-WIDE OR PROGRAM-SPECIFIC

Campus-Wide vs. Program-Specific

An undergraduate major or campus is designated as impacted when the number of applications received from fully qualified applicants during the initial filing period exceeds the number of available spaces. Such majors or campuses are permitted to use supplementary admission criteria to screen applications.

Consideration for admission to any impacted major or campus is contingent on first meeting the regular admission requirements for the CSU. Supplementary admission criteria are used to screen all applicants for admission to impacted majors including those students currently enrolled at the campus in other majors and seeking access to the impacted major. Transfer students have the same priority as continuing students in being admitted to an impacted major. They must also meet the same supplemental admission criteria as continuing students.

Campus impaction (otherwise known as campus-wide impaction) means that a campus has exhausted existing enrollment capacity in terms of the instructional resources and physical capacity of the campus. Because the campus receives more eligible applicants during the initial admission application filing period than can be accommodated, the campus must therefore restrict enrollment to the campus.

Major impaction means that the number of applications from fully eligible students to a designated major during the initial filing period far exceeds the number of spaces available in that major. However, students can still be admitted in an alternate major, or they may eventually be admitted to the oversubscribed major if they meet the supplementary admission criteria.

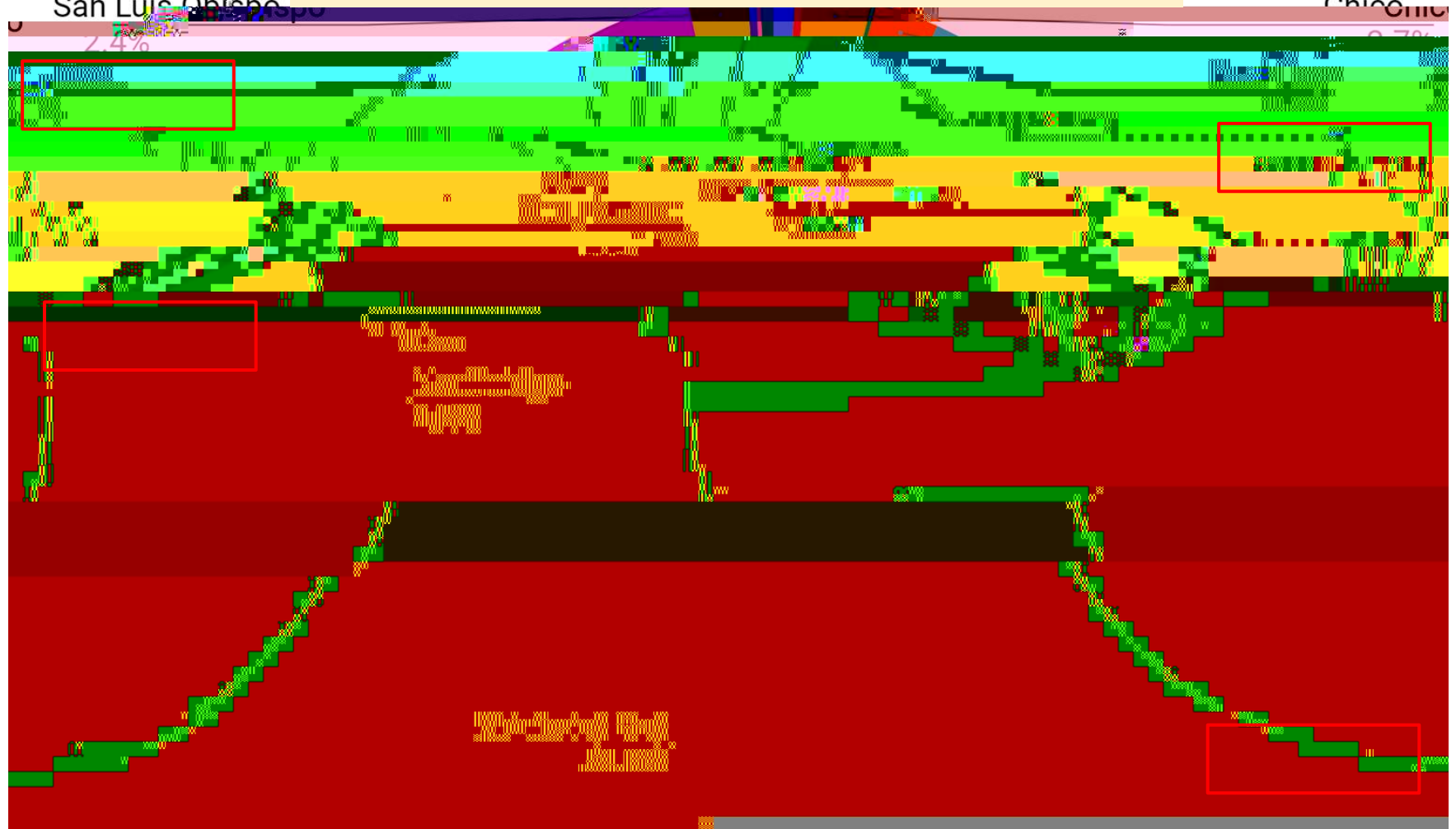
TRANSFER STUDENTS' ENROLLMENT OVER LAST 5 ACADEMIC YEARS

IMPACTION= COMPETITIVE ADMISSION PROCESS

CURRENTLY (SINCE 2012):

San José State gives preference in the competitive admission process to “local” applicants. For freshmen, you are considered a “local” applicant if you will graduate from a high school in Santa Clara County. For transfer applicants, you are considered a “local” applicant if you will earn the majority of your transferable units at a college located in Santa Clara or Santa Cruz county.

All applicants are strongly encouraged to apply to an alternative campus that offers your preferred major.

2019-2020 PROPOSAL BY SJSU

"For the fall 2019 admission cycle, we will prioritize local residents by adding a 0.25 GPA bump when making admission decisions whereas our previous GPA bump was a 0.2. Expanding our local admissions area would advantage a greater number of Bay Area students in the admission process and better serve our region in offering broader access to our unique and iconic programs of study that are in high demand. As an example, we offer 13 undergraduate programs in our Charles W. Davidson College of Engineering, the most of any Bay Area university. Our current designation of local admissions area has also limited our efforts to ensure that our campus better reflects a more representative student body relative to the state of California. Our proposed admissions area expansion includes Alameda, Contra Costa, San Francisco and San Mateo counties for transfer students and these same counties plus Santa Cruz for first-time freshmen."
